Proposed Omnibus Amendment to Local Planning Scheme No.5

In Sep 2019, Council resolved to undertake an omnibus amendment of the Shire's Local Planning Scheme No.5. This followed the July 2019 decision where Council rejected a full review of the local planning scheme, as the cost was outside the Shire's budget position.

The Omnibus is a smaller review of selected items which have immediate concern to the Shire, either by regulatory obligation or they're items where recent issues have brought their attention to the Shire. The entire process takes 12-15months and has been underway for 7 months to date.

Once the proposed amendments are made available for public inspection, they must be open for public comment for a period of 42 days (regulatory obligation). The Shire of Victoria Plains has given 64 days for this process. Submissions are due by Friday 15th May 2020.

The Shire originally planned a public meeting on the 16th April, to allow the community to ask questions to the Shire's Planner. Given the restrictions of COVID19 on public meetings, the Shire's Planner Mr Joe Douglas, has provided his mobile phone number & email address, to which the community has the same opportunity to ask those questions.

Submissions may only be submitted in writing to the CEO. Verbal submissions or opinion cannot be provided, even at a public meeting. Therefore the COVID19 restrictions have only changed the method of asking questions to the Shire's Planner.

The Shire encourages the community to read the items proposed for amendment. If you have questions or concerns, give the Shire's Planner a call or email to discuss. Then submit your submission to the Shire by the 15th May. The Shire accepts both for & against submissions. They must be submitted to the Shire's Chief Executive Officer (not Councillors) via email at <u>reception@victoriaplains.wa.gov.au</u> or posted to PO Box 21 CALINGIRI WA 6569. All submissions must include the following information:

- Your name, address and contact telephone number;
- How your interests are affected whether as a private citizen, on behalf of a company or other organisation, or as an owner or occupier of property;
- Address of property affected (if applicable); and

• Whether your submission is in support of or objecting to the proposal, either in part or in whole, and any reasons supporting your comments.
