# From the CEO...

The budget for the 2025/26 financial year was adopted by Council at the Ordinary Council meeting held 30 July 2025.

2024/25 further consolidated a number of legacy projects and for the first time in many years, the shire has caught up with the Road Construction Program, some of the backlog dating back to 2018.

Highlights of achievements from the Strategic Community Plan includes:

- Community Local Heritage Survey, Sport and Recreation quick wins, reinvigoration of the Local Emergency Management Committee.
- Economy budgeted road construction completion of the Mogumber-Yarrawindah Rd, Calingiri – New Norcia Intersection and Toodyay -Bindi Bindi Rd, Water Projects and successful Housing Support Program funding.
- Environment Progress on Waste Transfer Stations, Corella Management.
- Civic Computer system improvements, Compliance improvements, strategic planning reviews.

For the longer term, there has been significant progress and advocacy in energy transition with wind farms, Caravel Mining and the European Space Agency (ESA), all major projects that will have a once in a generation impact on the shire.

Given the scale of upcoming major projects, the next five years will be financially challenging for the Shire, with economic benefits likely to follow only after these projects are established through the multiplier effect on the local economy.


For 2025/26 council was advised that the Local Government Cost Index (LGCI) a measure of inflationary costs to local governments and calculated independently, forecast a 3.3% increase. In order to continue momentum, deliver strategic outcomes and position the shire, it was necessary to increase rates by 7% for the 2025/26 financial year.

Accordingly, my focus will be in four key areas:

- Housing
- Renewables
- European Space Agency Tourism
- Mining

Which in time and success, will see a very different Shire of Victoria Plains in both landscape, employment and industry development.





Apart from the above, the Shire will be undertaking 36 strategic actions regarding Community, Economy, Environment and Civic Governance.

# Regulatory Services (Health, Food premises, Septic Tanks, Building and Planning)

- The Shire's Environmental Health Officer, Gordon Houston, has many years' experience in local government and continues to assist residents and businesses with environmental approvals and public health issues including applications for food businesses and events, installation of septic's, pollution issues and general environmental health support and education.
- Gordon also acts as a conduit for all Building and Planning enquiries as well as Shire property management issues within the Shire of Victoria Plains.
  Generally, Gordon attends the Calingiri offices each Tuesday but can be contacted anytime by ringing the Shire on (08) 9628 7004 or via email at <a href="mailto:ehobs@victoriaplains.wa.gov.au">ehobs@victoriaplains.wa.gov.au</a>. - The Shire also engages the expert services of a consultant town planner, Joe Douglas, who is based in Perth and is available to help with any planning or development enquiries. You are encouraged to contact Joe in the early stages of your proposal to ensure you are aware of the Shire's requirements when planning your new development. ### **Infrastructure Services - Works Department**

- For enquiries relating to the maintenance of roads, footpaths, drains, culverts, parks and gardens and other outside works please contact the reception team on (08) 9628 7004. For all after-hours reporting please phone the shire office on (08) 9628 7004, the operator will direct your enquiry to the staff member on call, or a report will be lodged to the shire reception if it is deemed a non-urgent issue. The Works Manager mobile will no longer be monitored for any works requests.
- Roads to Recovery (R2R) program will see Yerecoin Southeast Rd widened 1.75 meters each side the to the boundary and a full 14mm re-seal the following year.
- A new funding stream will include road edge widening and audible line marking treatment to Toodyay-Bindi-Bindi Rd from the Toodyay boundary to the Goomalling Rd "T" junction. This is a 50% state and 50% federally funded project- Regional Road Safety Program. This is a phased project of 5 years, with this being the first. Main Roads identify and nominate the roads to be done.

## <u>Mogumber</u>

No direct opening hours. Keys are available from the Shire Administration Office subject to Shire approval. This can be arranged and collected from the Shire Administration Office in Calingiri. A key bond is required.

#### **Changes to our Waste Stream**

Over the next few months, each tip site will start to look different as we move to Transfer Station Operations. This will not affect what you bring to the tip or the opening hours. It will, however, require users to be more selective in what is deposited so that waste streams can be sorted effectively. This will mean users will need to separate their waste material into waste types. All putrescible waste will go into large bins in the concrete bunkers for removal to another site.

# Tip Passes

Tip passes are issued as a way to support responsible waste disposal by providing residents with controlled, subsidized access to waste facilities. These passes allow individuals to dispose of certain types and volumes of waste—often bulky or excess household items—at designated sites without incurring standard tipping fees.

- Each property assessment will be issued with one tip pass annually.
- If you require more than one tip pass for your property, please contact Shire administration to seek requirements on how to obtain extra passes.

#### Lost/Replace

- Ratepayer to attend Administration Office
- Advise of your Property Assessment Number
- Tip passes can only be arranged/collected by the property owner. NO exemptions for tenants.
- The lost tip pass will now be cancelled/no longer useable.

# Animal Legislation and Fees



# DOGS

- Dog and cat owners are required <u>by law</u> to register their animals. Owners have the option of registering their animals for a period of One Year, Three Years or Lifetime.
- To assist our dog and cat control measures, please ensure your animal is microchipped and registered which will assist the shire to identify the owner enabling us to return the animal as soon as possible.
- Animals up to 12 weeks of age are entitled to the discount of 50% if they are first time registrations that takes effect after 31 May and before 1 November in the year of the first registration. To obtain Sterilised concessions, owners must produce a Registered Veterinary Sterilisation Certificate. Amendments to the Dog Act requirements, from 1 November 2015 all dogs must be microchipped.
- Dogs over the age of three months, and cats over the age of six months must be registered and microchipped. Registrations expire on the 31st of October and can be renewed for 1 or 3 years from that point onward.

# **CATS**

The Cat Act 2011 was introduced by the State Government with the aim of encouraging responsible pet ownership and reducing the number of unwanted cats across Western Australia.

From 1 November 2013, under the Cat Act, owners of cats (over the age of 6 months) must ensure they have their feline pets:

- 1. Microchipped, wearing a collar and registration tags (for identification purposes if the animal becomes lost or injured)
- 2. Sterilised unless being used for breeding purposes with the approval of the Shire of Victoria Plains
- 3. Registered Local Government officers are authorised and may enforce this legislation, and fines will apply to owners who do not comply

# Rates Notice Additional Information

#### **Interest on Overdue Rates and Charges**

An interest charge of 7% per annum will be applied to all overdue rates. Interest will be charged on rates remaining unpaid thirty-five (35) days after date of issue of the rates notice.

**Instalment Options and Due Dates** 

The following options are available to all ratepayers:

- 1. Full payment by due date (35 days after the date of issue of the Rates Notice)
- 2. Payment by four instalments incurring an administration fee of \$10.00 per instalment notice. Interest charged at 5.5% per annum will apply

#### **Alternative Arrangements**

Ratepayers experiencing financial difficulty should contact the Rates Officer in writing as soon as they receive their rates notice to discuss alternative payment arrangements.

# Pensioner and Senior Card Holders Concession

Holders of a Pension Concession Card, Seniors Card or Commonwealth Health Care Card are eligible for a rebate on current shire, ESL and sewerage rates (subject to certain conditions). Property owners should contact the Water Corporation on 1300 659 951 (8am - 5pm weekdays). The Water Corporation will advise the shire, and the concession rebate will be applied to your rates. If the customer has received a concession rebate on their rates and do not pay by the end of the financial year, **NO** rebate will be accepted and payment in full will be required.

## **Emergency Services Levy**

A levy is included on all rates assessments. Money is collected on behalf of the Department of Fire and Emergency Services. The levy goes toward the upgrading of firefighting facilities and equipment within the shire. The minimum ESL charge for 2025/2026 is \$108.00.

#### **Question Time**

In accordance with the Section 5.24 of the Local Government Act 1995, the Council Meeting Agenda will include Public Question Time, and this will be held shortly after commencement of the meeting. The minimum time for this section within the Meeting is 15 minutes (in total, not per person)— assuming there are sufficient questions to fill that period. A 'Public Question Time Form' is available on the website and Members of the Public are encouraged to use and submit that form by 12 noon the day before the meeting, so that staff can research the question prior to the meeting in order to provide an accurate response. The Presiding Member has the discretion to nominate a maximum of 2 questions per person as deemed necessary to facilitate the effective running of the Meeting.
