Fees and Charges

The following fees and charges apply to an FOI application for non-personal information

- 9. If the Shire estimates that the charges involved in dealing with an application will exceed **\$25.00** (on top of the **\$30.00** application fee) then a written estimate will be provided to the applicant who will be asked if they want to proceed.
- 10. The Shire may ask for payment in advance of up to **75%** of the total estimated costs in certain circumstances.

A standard reduction of **25%** is to be applied to charges payable by applicants who are financially disadvantaged including applicants who are a holder of a current Pension Health Benefits Card or Concession Card issued by the Commonwealth Government. An applicant who does not have the money to pay any estimated charges should advise the Shire and ask for the charges to be reconsidered.
