

## From the Shire President Pauline Bantock

During the last week of June, I joined our CEO and over 1300 people from the Local Government Sector at the Annual General Assembly in Canberra. Local Governments from all around Australia send Council leaders to advocate for better federal funding, policy reforms and effective partnerships.

The national event begins with the one-day Regional Forum where we discussed some of the big topics such as the changing role of regional disaster resilience, stronger road networks and regional health. I particularly found the presentation on regional demographics from Bernard Salt very interesting, predicting a 25% increase in population over the next 40yrs, requiring a 40% lift in food production. The need for food and resources will continue to lift focus on regional areas like Victoria Plains.

During the Annual General Assembly, voting delegates went through 192 motions which are proposed from all corners of Australia. There were a few motions which absolutely had my head shaking in disbelief, showing a real misunderstanding of regional Australia from some of the larger city councils. But overall, most motions will help the Australian Local Government Association advocate for the funding and policies that we really need.

I thank our CEO Sean and Council's support officer Julie, for arranging some important meetings while we were in Canberra. Sean led a group of Wheatbelt CEO's & Presidents through a meeting with the Director of the Housing Support Program, discussing the Wheatbelt Regional Housing Initiative to develop 459 new homes across the 10 shires. We were reminded how successful our application was, receiving \$32.8 million in a very competitive grant process, to commence the head work development. We can't wait for the funding distribution to commence so we can get going on the project.

Representatives from the Avon Regional Organisation of Councils met with newly elected Federal MP Trish Cook, discussing matters such as the energy transition and phase out of live sheep export. We are planning a round table meeting between AROC and Ministers later in the year and thank MP Cook for helping us with the arrangements. Strength in numbers also helped us discuss points with Minister Kristy McBain's office, the Minister for Regional Development and Local Government.

On our final day in Canberra, Sean & I met with the Coordinator-General for the National Emergency Management Agency. It was lovely to hear that Brendan Moon had an understanding of Victoria Plains, as he told us stories of visiting family in Calingiri, driving a harvester during his early years.

We arrived back to WA in the late hours of Friday night and yes, the event can be a bit draining at times. Imagine some of the strongest personalities from each Local Government in Australia in one room, discussing the big topics and flighting for our local communities. However, I can honestly say I come home from the National General Assembly invigorated and inspired. It reminds us why we are involved in local government and particularly reminds me of the need to constantly advocate for our communities and push our needs to the top of the priority list.

### From the Chief Executive Officer

### Sean Fletcher

During June and into July, the Shire has been busy with not only closing out the 24/25 financial year but undertaking advocacy at the State and Commonwealth level.



During 23 – 27 June, the Shire President and I attended Local Government Week in Canberra, along with 1,300 other local government representatives from across the nation. This consisted of participating in, and advocating as follows:

- The Australian and Regional Economic Forum, including the increase in Australia's population by 4M in the next 10 years and the need to increase our productivity by 20 40% and addressing regions that are losing population. It was interesting to note the strong trend of people returning to country areas;
- The Main Congress, including a speech by the Governor General and workshops regarding emergency management and social housing;
- The Ministerial Briefing Sessions including ministers Hon. Kristy McBain and Hon. Josh Wilson;
- Eight Meetings regarding the following:
  - i. Housing Support Program confirming the arrangements that will see the Shire receive \$4.5M to develop the Edmond Street development;
  - Woodside regarding its Carbon Offset program in the Shire;
  - iii. Renewable Energy Matters including working with other local governments on the development of a submission in response to PoweringWAs Draft Community Benefits Guideline;
  - iv. Wheatbelt GP (Doctor) Matters there is now a Wheatbelt alliance to develop the case for better doctor provision in the Wheatbelt;
  - v. Brendan Moon, the Coordinator General of the National Emergency Management Agency regarding the Shire's AGRN 962 flood claim from March 2021.
  - vi. Trish Cook MP, the Member for Bullwinkle re AROC matters, as three of the five AROC local governments are in her electorate.

Our face to face advocacy has been important in not only resolving issues but in terms of securing funding for key projects and community outcomes.

#### The Energy Transition and Community Benefit Contributions

As I have been letting you know for a while now, Western Australia is undergoing a rapid energy shift or transition and local communities—particularly in rural and regional areas—are at the frontline of hosting large-scale

renewable energy projects. These projects offer economic and social opportunities but also introduce complex local impacts and risks for the communities that will host these developments and neighbouring communities alike, with some areas experiencing concentrated development activity.

The design and development of renewable energy projects has outpaced planning at a Federal and State Government level and Local Governments, especially those in regional Western Australia, have been left to fill the void. As we know, the Shire of Victoria Plains is also impacted by the same situation.

Both the Shire President and I are on the WALGA Large Scale Renewable Energy Working Group and have worked with the other stake holders to produce the Renewable Energy Community Benefits and Engagement Guide. WALGA released the Guide on 9 July 2025, to assist Local Governments navigate large-scale renewable energy projects. The Guide, developed by WALGA in consultation with Local Government, State Government and industry, is designed to support Local Governments in dealing with large-scale renewable energy projects. The Guide provides Local Governments with a practical framework to understand their role, engage with developers and their communities and advocate for lasting economic benefits from these projects.

The Guide also contains useful information that you can access regarding what the Energy Transition is, the need for community benefits and how to advocate with renewable energy providers.

In addition to the above, the Shire has met PoweringWA on a number of occasions now regarding the Energy Transition and the development of appropriate policies regarding the State's plan. These meetings have been very successful and have seen the Shire's advocacy regarding community benefits, housing impacts and community engagement taken on board.

PoweringWA has now issued a consultation paper: Draft Guideline on Community Benefits for Renewable Energy Projects. The WA Government welcomes views from local communities, landholders, local governments, potential and current renewable energy developers and all Western Australians with an interest in the energy transition. The feedback period closes on 18 August 2025.

This Guideline points out that the purpose of this paper is to respond to requests from communities and renewable energy developers to provide a resource for determining appropriate community benefits arrangements for renewable energy infrastructure. This guideline can be applied to renewable energy generation infrastructure such as wind turbines, solar farms and batteries. The principles in this guideline are broad and can be applied across WA. However, many of the suggested benefits values are most relevant to projects in the State's South-West, especially those intending to connect to the South West Interconnected System (SWIS).

Community benefits are only one part of social performance for renewable energy projects, and there are many other ways that projects can contribute to local communities. It is expected that projects will follow best practice in how they are developed, including local training and employment, procurement of goods and services and development and use of local infrastructure. Renewable energy projects are only a subset of electricity infrastructure – for instance, social performance for transmission infrastructure is also important and will be considered separately

Further to this advocacy work, both the President and I have been working with other Wheatbelt local governments regarding the development of a submission that we can submit to this draft guideline.

Both the President and I have been invited to the Regional Leaders Summit regarding Renewable Energy Developments in Newcastle, NSW in early August. This is so that we can continue our advocacy work regarding the Energy Transition both at the National and at the State level. Our attendance is made possible through support provided by PoweringWA.

A busy time for the finance and admin team as we try to finalise the new budget 25-26 and End of Financial Year statements position which has an impact on the budget so this will be relatively short:

#### Finance:

The Capital Projects have virtually been completed with some carry overs primarily to either unfavourable weather conditions or delay in supplier goods. The list of completed projects is significant and I will provide this in a later edition but for now I will advise those capital items carried forward (C/F) into 25-26



## From the Emergency Management Officer Jack Van Voorst

Over the past month the emergency management team has continued to bolster the Shires emergency management capacity and outreach through our Joint Shire of Victoria Plains and Shire of Wongan-Ballidu Local Emergency Management committee. The committee held a successful emergency response exercise followed by a productive meeting and debrief with a number of lessons learned that will further guide our response to emergencies that occur within our local communities.



#### Exercise "Bitter Road"

On Saturday 14 June 2025, the Shire of Victoria Plains and Shire of Wongan-Ballidu conducted a Joint Local Emergency Management Committee (LEMC) Emergency Training Exercise.

Held at the intersection of Depot Road and Short Street in Wongan Hills, the scenario involved a ute crash into a power pole, carrying an IBC of Paraquat—a hazardous agricultural chemical. The exercise incorporated hazmat and road crash elements, with five mock casualties.

Nearly 40 participants from a range of agencies and organisations took part, including Western Power, Department of Fire and Emergency Services (DFES), Wongan Hills Police, Wongan Hills St John Ambulance, Wongan Hills Volunteer Fire and Rescue Service, Ballidu Volunteer Fire and Emergency Service, Wongan Hills District High School YES Cadets, and representatives from both Shires.

The exercise tested multi-agency response, including scene control transitions between WA Police and DFES, chemical identification, safe extrication, decontamination, and coordination using the Shire's Local Emergency Management Arrangements. It was a valuable learning experience that reinforced the importance of collaboration, clarified roles and responsibilities, and helped identify local resources.

These exercises are essential in ensuring our community is ready and resilient in times of crisis. Thank you to all involved for your commitment to community safety.

#### **BFB** training

Training for BFB volunteers is now underway, the shire has established a local joint training with Shire of Wongan-Ballidu. A number of courses from the Basics to the more advanced courses are being held. Training is great way to boost your knowledge and pick up on some new ideas.

The next introductory courses (Bushfire Safety Awareness and Firefighting Skills) are set to be held at the beginning of August. We are currently taking enrolments! These are the two courses which are a requirement in order to turn out with the Shire BFB appliances.





### **Polyphagous Shot-Hole Borer**

The State Government has recently announced that it has been determined that eradication of the PSHB is no longer technically feasible and that the decision has been made to transition to long-term management. As indicated in WALGA's media release, this decision is a result of the inadequacy of the State's PSHB response. It is unacceptable that Local Governments now face the additional, ongoing costs of managing infected trees in public parks and streets.



This beetle poses a significant risk to farmers in Western Australia, particularly due to its ability to attack a wide range of host plants, including many common agricultural crops. The beetle introduces a fungus into trees, which blocks the flow of water and nutrients, ultimately leading to tree death. This can severely impact fruit and nut orchards, as well as other valuable agricultural trees. We ask everyone to help do their part to try stop this beetle and keep an eye out for it and be mindful of where you purchase soil and plants from.




