# **Background**

Each year Council is required to complete a compliance audit return to ensure that the operations of the organisation are complying with the Local Government Act 1995 and associated regulations.

#### Comment

This report aims to highlight the areas of non-compliance, and detail remedial action proposed to be taken in regard to instances of non-compliance.

The items of non-compliance were:

- 1. The Local Laws review under section 3.16(1) was commenced by the previous CEO and put to one side in an archive box and forgotten about.
- 2. Where a decision of Council varies significantly from the officer's written recommendation then a written reason should be included in the minutes this was not done at the October 2005 meeting and although raised at the November 2005 meeting when confirming the minutes for October no clear reason was established and so no written reason was included in those minutes.

3. The contract of employment for the CEO and all designated senior employees details the maximum amount of money payable if the contract is terminated before the expiry date and this amount is the lesser of the value of (a) one years remuneration under the contract or (b) the value of the remuneration they would be entitled to if the contract was not terminated.

The remedial actions proposed in relation to these items of non-compliance are;

- The CEO and senior staff will ensure that a review of all local laws is completed as soon as possible, local laws in Victoria Plains other than Health local laws (which have been reviewed) are the model local laws and the absence of a review has not caused any inconvenience.
- 2. The CEO has advised Councillors and the Shire President of this requirement and will ensure that where this occurs in future a written reason will be included in the minutes.
- 3. The contracts for the CEO and senior staff were either drawn up before the amendments to the act and associated regulations were gazetted or the provisions of section 5.39 (3)(c) and Admin regulation 18B were over looked in the renewal process and will be rectified by an addendum to the contracts.

Council is required to adopt the return and endorse remedial actions before the return is submitted to the Department of Local Government and regional Development.
