FOR AN ORDINARY MEETING OF COUNCIL HELD ON TUESDAY 21st OCTOBER 2003 AT COUNCIL CHAMBERS CALINGIRI COMMENCING AT 1.00PM.

1 DECLARATION OF OPENING AND ANNOUNCEMENT OF VISITORS

The Presiding Member declared the meeting open at 1.00pm and welcomed Mr John Rossiter from Main Roads.

Mr Rossiter addressed Council on the difficulties associated with road networks for heavy transport and the various policies in neighbouring shires.

Main Roads WA is seeking to set up a three tier approach where:-

- Tier 1 Main Roads will develop a network of "through roads" in each shire for heavy transport vehicles to use. These will generally be MRWA Roads.
- Tier 2 Local Access Network will be those roads available to local carters to access farms.
- Tier 3 Temporary Access Roads for use only at busy times i.e. harvesting.

Discussion ensued on configurations for hay carting, and neighbouring shires needing to get together to come up with a network plan for a "continuous access route".

Background

As Councillors are aware special building licence conditions relating to the relocated dwelling at Lot 182 Poincare St Bolgart were not completed by the agreed times (15th April 2002). Continued pressure to have the outstanding conditions complied with has resulted in the building being 95% complete at this point in time. On 30th January 2003 Mr Stock applied for planning consent to relocate a second hand timber framed games room to the rear of the partly completed dwelling. Mr Stock was advised in writing that

"approvals to relocate/erect further buildings on Lot 182 Poincare St will not be considered until conditions pursuant to the planning consent and special licence have been satisfied".

Comment

On Thursday 25th September 2003 inspection of Lot 182 Poincare St Bolgart revealed that a timber framed skid mounted structure has been relocated behind the existing dwelling, *without approval*. During discussion with Mr Stock he admitted that he had arranged to put the building there and he is aware that approval has not been granted by Council for the structure to be on the property.

Council has two options to deal with the matter:-

Firstly, Council could prosecute Mr Stock and request the court to order that the building be removed. The costs involved in mounting a prosecution of this nature would be in the region of \$1,000 to \$2,000. If a conviction was secured a fine would be awarded and costs awarded against the defendant. The costs awarded by the court may not reflect the amount outlayed to mount the prosecution. Recovering the costs awarded by the court from the defendant may involve significant further effort and financial outlay.

Secondly, Council may grant planning approval for the relocation of the building with strict conditions attached. In this case they would be:-

- Remove the "u" beam skid mountings and install an approved slab on ground footing or an approved stump footing system;
- Remove secondhand corrugated iron cladding from the building;
- Install a new hardiflex external cladding;
- Line the building internally with 10mm gyprock lining;
- Repaint the building inside and out in an approved tradesman like manner;
- Lodge a \$2000 bond or bank guarantee to ensure that the conditions are complied with.

Background

In the past Council has approved the relocation of buildings into the Shire with conditions which have proved very difficult to enforce.

Other Shires have addressed the problem of inappropriate buildings being transported into their municipal areas by the adoption of a Town Planning Policy.

Comment

Clause 8.5 of District Town Planning Scheme No. 4 gives Council the power to make policies. The procedure is, to prepare and adopt an appropriate policy to control relocated buildings. In order to make the policy operative the adopted draft policy needs to be advertised in a local paper once per week for two consecutive weeks. After twenty one days the draft policy is required to be reviewed and submissions considered. Final adoption can then be made. Notification of the final adoption is then required to be advertised once in a newspaper circulating in the Shire.

An appropriate policy needs to include the following to be effective:-

- 1. A requirement that the building proposed to be relocated be inspected by an officer of the council to determine the suitability of the building for relocation into the Shire of Victoria Plains and also to identify whether the building contains inappropriate materials (e.g. asbestos);
- 2. A requirement that all materials containing asbestos be removed from the building prior to transporting the building into the Shire;
- 3. That an approved bond or bank guarantee be lodged with the Council to ensure the satisfactory completion of any conditions of approval;
- 4. That a special building licence of specified duration be obtained from Council.

A draft Shire of Victoria Plains District Town Planning Scheme No. 4 Policy No. 1 (Relocated Buildings) is attached to this report. Should an applicant be aggrieved by a Council decision an appeal right exists.

Background

As Councillors are aware Council Policy has been to make no comment on the trials etc for Roundup Ready Canola in the past. The Office of Gene Technology has now approved Genetically Modified Canola for commercial release but at this time the State Government have not agreed and as I understand it the Ag Department should be monitoring trials.

We have again been asked to comment on the Risk Assessment and Risk Management Plan which the Gene Technology Regulator will use to form a basis for a licence issue.

Comment

There have been a number of comments on the issue since the public became aware of trials in our Shire. I believe that it may still be better to retain our policy of no comment as a Shire as it raises strong opinions both for and against and unless we have a clear indication from the public one way or the other a neutral stance appears to be the best option. The state Government is working towards a policy for this state on the use of G.M.O.'s.

It is also noted that WALGA has adopted the following policy position:-

- 1. A moratorium of 3 years on the commercial production of G.M.O.'s be supported;
- 2. Responsibility is given to an appropriate agency, which undertakes the following:-
 - Research the effects of G.M.O.'s on the receiving environment, non GMO crops, human health, (food production and consumption) social and economic impacts and any related ethical considerations;
 - Public dissemination of information on the above research which is independent and defendable;
 - Development of a comprehensive monitoring and surveillance framework to track GMO products and the above effects; and
 - Development and administration of a system to control the production, distribution and sale of GMO crops and foods.
- 3. With particular emphasis on the establishment of GMO free zones, the legislative framework regulating G.M.O.'s and its relationship with State and Commonwealth legislation is researched and clarified with an aim to providing for public participation;
- 4. Ongoing research (field and laboratory) into G.M.O.'s is supported provided such research is conducted under strict containment and monitoring conditions.
