Background

A number of releases have been received and copies forwarded to Councillors regarding the action of the State Government in slashing \$14.2M from Local Government Road Funding and breaking the pre-election commitment of the Premier to maintain Local Government Road Funding under the State Road Funds to Local Government Agreement which runs until 2005.

Comment

In our case from previous information given to the Regional Road Group it appears that we will lose about \$28,000 from our allocation which is committed to the resealing of the Toodyay-Bindi Bindi Road and reduce the length of the reseal possible thus extending that project.

The breaking of the election promise by the Premier is of concern however it is another in a long line of broken election promises. Also of concern is the comment by the Minister for Transport and Infrastructure that as we receive additional funds from the Roads to Recovery Federal Grants the cuts will have little impact.

As Council is aware we have been continually without success seeking confirmation of funding in the year 2003/2004 for continuing the AgLime Route Construction. The release of the State Budget confirmed our fears that funding would be withdrawn. There is no allocation in 2003/2004 for this work in the State Budget allocations.

Comment

I have managed to contact John Clydesdale of the Ministers Office who has confirmed that no funding is allowed in 2003/2004. He has advised that forward estimates allow for \$2.5M to be spent in the four years forward estimates. He advises that the Minister is considering options of bringing forward future allocations to 2003/2004 as happened with funding this year that was from 2003/2004 to this year. We can expect contact from the Minister regarding this in the next two weeks.

Background

During the construction of the Grain Storage Facility site at Calingiri information was put forward to Cooperative Bulk Handling to supply and erect a sign on Calingiri New Norcia Road near the CBH Terminal to bring to the attention of motorists that if the railway line was blocked by trains loading grain that an alternative would be made available to "Emergency Vehicles" through the worksite area of CBH and onto the section of Bin Road at the Eastern end to link up with the Calingiri West Road.

Comment

This was discussed at the time with CBH, the Shire of Victoria Plains and Main Roads whilst the facility was under construction. A recommendation was made to CBH from Main Roads that a sign be provided by CBH and erected to alert traffic of an alternative route. The sign shall read:-

USE CALINGIRI ROAD CROSSING WHEN CALINGIRI NEW NORCIA ROAD LEVEL CROSSING IS BLOCKED ACCESS VIA BIN ROAD AND CBH SITE

The sign is to be reflective blue background, 10mm high white lettering and a border and will be located between the Level Crossing and CBH access of the Southern side of the roadway.

Chief Executive Officer's Report to Plant and Works Committee Meeting 27th May 2003

Funding 2003/2004

As per the Agenda the funding for the AgLime Route 2 was not included in the Budget Papers, however we may still be allocated some funding from the forward estimates to allow the works to continue. We are hopeful of early advice in this regard. We have again been successful with Black Spot Funding which will offset Regional Road Group decreases.

Drought Proofing Calingiri

This proposal drags on and I am hopeful that we are moving towards a conclusion. The water source has been established and the licence approved. Planning for the project is expected to be received from the Consultants by 21st May 2003 and we hope to receive approval from the Water Corporation quickly. I am hopeful that I can defer funding from external sources as funds were proposed to be expended by 30th June 2003. Personally this project has been a grind and I am hoping to wrap it up as soon as possible.

Staff

I would like to discuss with the Committee the need to increase our Works Staff by a further permanent employee in the forthcoming budget. During the 90's Works Staff were reduced and this has placed a strain on our activities. This year because of the huge increase in the Works Program we have utilised casual staff for most of the year but even with a standard program the need to utilise Town Maintenance staff on rollers or other tasks in the field has meant that we are not maintaining our towns to a sufficient standard.

The Works Manager and myself have discussed this issue and believe that we can dedicate a person to this task by increasing our workforce by one and this right person given a deal of freedom to allocate his own priorities and work without continual supervision could make an impact and reflect creditably on the Shire and the public. Maintenance of our towns is an area where we receive a deal of criticism whether warranted or not. It would be important that this employee not be taken from his/her duties unless absolutely necessary.

Works Manager's Report to Plant and Works Committee Meeting 27th May 2003

Construction

Calingiri-New Norcia Road/Calingiri-Goomalling Road - AgLime Route 2

To date all the construction work on AgLime Route 2 is going to plan, however over the last week or so we have had some difficulties with the weather which is normal for this time of the year and the construction process has slowed somewhat, this is mainly affecting the western end of Route 2 construction at the Carani end.

Calingiri-New Norcia Road has been completed to a primer seal stage over 4.3 km x 7.0 m to join up with the old seal west of Calingiri and I am very pleased with the result of the completed section.

Calingiri-Goomalling section of AgLime Route 2 over 1.20 km x 7m wide is complete past Brian Slater's property to a primer seal stage this is the only section programmed for total reconstruction and prime this financial year.

The loose material will be swept from the primer seal and guide posts will be erected after the sweeping is carried out.

Calingiri-New Norcia AgLime Route at the Carani end is progressing well and on budget, however as mentioned previously the weather has been a factor in the past few days.

I have had discussions with Roadswest and Main Roads in relation to the completion of the primer seal on the Carani section which will cover approximately 4.30 km x 7m in width and the effect that the wet weather may have in relation to the primer seal being completed this financial year.

As Council are aware Main Roads expected us to complete with the monies allocated this financial year 6.2 km of total reconstruction and primer seal on AgLime Route 2 as Council can see we will achieve more like 11.0 km of total reconstruction and primer seal on AgLime Route 2 this financial year.

However in saying that, if the wet weather persists and the primer seal cannot be laid on this section this financial year, all the materials to complete the prime have been purchased and paid for this financial year, with sanction from Roadswest and Main Roads.

If we do run into very wet weather, and the prime cannot be achieved over this section the material will be waterbound to provide a very good running surface for traffic until mid October 2004 after the winter rains.

If weather conditions improve and we can apply the primer seal all will be achieved in 2002/2003 financial year. As Manager Works Services I will not take the risk of applying the primer seal if conditions are not favourable once the material has been waterbound.

Main Roads and Roadswest are happy with this proposal if the weather creates any major problems for us to finish the programme within 2002/2003.

All materials including signs and guide posts have been purchased this financial year for the AgLime Route 2 Construction for the total length between Great Northern Hwy and the Goomalling Boundary.

Behanging Road

Various sections to widen and seal inside curves, improve visibility and gravel re-sheeting various.

Corondine Road

Tree Lopping, Drainage Construction to 2.0 km x 8m wide gravel re-sheeting from Fordham Road towards Wyening Mission.

Thompson Road

Two box culverts will be installed within the first week of June 2003 this work may have to be carried out by a contractor as our staff are very busy with construction works.

Old Plains Road

Not on this years budget allocation. This was completed under maintenance 1.20 km x 8m wide from Yenart Road to Great Northern hwy.

Drainage Maintenance

Work will start early June 2003 on cleaning out blocked culverts and drains around the shire as required.

Maintenance Grading

Maintenance grading will continue whilst weather permits and this will be ongoing as time allows. At present I have engaged a contractor RJ &BR Hogg to carry out some maintenance grading as directed by myself while our machines are busy with construction and Capital works including the AgLime Route.

Parks & Gardens Maintenance

Maintenance of the Calingiri hockey and football fields has been ongoing. This work is carried out as time allows from other maintenance and construction works. Town maintenance has

continued as time allows i.e.: mowing, spraying, guide posts, street and road signs, verge spraying.
