

Local Government Act 1995

Shire of Victoria Plains Amendment Local Law 2025

Under the powers conferred by the *Local Government Act 1995*, and all other powers enabling it, the Council of the Shire of Victoria Plains resolved on **date when local law is 'made'** to make the following local law:

1. Citation

This local law is cited as the *Shire of Victoria Plains Amendment Local Law 2025*.

2. Commencement

This local law comes into operation 14 days after its publication in the *Government Gazette*.

3. Public Places and Local Government Property Local Law 2018 amended

In clause 1.6 of the *Shire of Victoria Plains Public Places and Local Government Property Local Law 2018* published in the *Government Gazette* on 4 September 2018, the definition of 'UAV' is amended by inserting the word 'Safety' immediately after the word 'Aviation'.

4. Extractive Industries Local Law 2018 amended

The *Shire of Victoria Plains Extractive Industries Local Law 2018* published in the *Government Gazette* is amended as follows:

- (1) In clause 3.2(2)(f), the words 'clause 3.1(3) are deleted;
- (2) In clause 3.2(2)(j), the words 'regulation 5 of the *Environmental Protection (Clearing of Native Vegetation Regulations 2004)* are deleted and replaced with 'section 51C(a) of the *Environmental Protection Act 1986*';
- (3) In clause 4.1(h), the words 'subclauses 3.2(1) and (2)' are replaced with 'clause 3.2';
- (4) In clause 4.6(6), the words 'or refuses to renew' are inserted after the word 'renews';
- (5) In clause 4.7(6) the words 'or refuses to approve' are inserted after the word 'approves';
- (6) In clause 4.8(4) the words 'or refuses to approve' are inserted after the word 'approves';
- (7) Clause 7.4 is amended by the addition of subclause (2) as follows:
'(2) Subclause 7.4(1)(b)(i) is subject to sections 3.25 and 3.27 and Schedules 3.1 and 3.2 of the Act.'
- (8) In clause 8.3(1)(b) the word 'done' is inserted after the word 'been';
- (9) Clause 8.3(2) is replaced with the following:
'8.3(2) Subclause 8.3(1) is subject to sections 3.25 and 3.27, and Schedules 3.1 and 3.2 of the Act.'
- (10) Insert a new clause 8.4 as follows:
'8.4 Any power of entry exercised by the local government under this local law is subject to Part 3, Division 3, Subdivision 3 of the Act.'; and
- (11) Clause 9.1(b) is amended by inserting the word 'transfer after 'vary'.
